



System Functionality

The broad set of functionality in the Occupational Licensing Civic Application covers applications and renewals, notifications, fees, assignment of tasks, and reports.

Functions

Online License Application and Renewal	Individuals or businesses can apply for a license, submit required documents, pay fees, and track their progress online.
Online Payments	License applicants can pay their license fees online, via Forte, ACI, PayPal, and others.
Automated Workflow & Task Management	Agency staff manages the licensing lifecycle from application submission to license issuance or renewal through automated work tasks and assignments.
Online License Verification	Citizens can verify active licenses with the county or city.
System Notifications	Pre-defined email notifications can be sent to an applicant (and other recipients) to communicate missing information, application status, and other critical updates.
Fee Calculations	Agencies can apply fees utilizing out-of-the-box formulas to ease the burden of complex fee calculations.

Automation/Notifications


Accela Occupational Licensing includes automation tools and configurable scripts to simplify the licensing and certification process.


Automated events are triggered based on user actions, time period, or other criteria, and automatically perform desired tasks, such as updating information or sending a notification to an applicant.

Additional Information Required	Automatically notifies applicants when additional information is required during the application review process.
Application Notifications Email	Informs users of an application's current status, approval, or denial through automated email notifications.
License Expiration Notifications	Notifies license holders their license is about to expire 30 days prior to the expiration date (or other configurable time period prior to expiration).
License Issuance	Informs the applicant the request for license has been issued.
License Denied	Informs the applicant the request for their license has been denied.

Individual License Form	License Issuance form for Apprentice Electrician Registration License, Apprentice Plumber Registration Application, Journey Electrician License Application, Journey Plumber License Application, Master Electrician License Application, and Master Plumber License Application
Individual License Form Renewal	License renewal form for Apprentice Electrician Registration Renewal, Apprentice Plumber Registration Renewal, Journey Electrician License Renewal, Journey Plumber License Renewal, Master Electrician License Renewal, and Master Plumber License Renewal
License Applications by Month	Displays the number of new applications by calendar month
Occupational License Certificate	Displays license details including applicant, address, and more
Outstanding Fees by Module	List of outstanding fees by module
Records by Status	Lists all records grouped by their status
Renewal Cycle Summary	Runs summary of license renewal based on profession or all
Workflow Activity	Lists workflow task status by record and user
